REACHING PROFESSIONALS WITH KNOWLEDGE AND SKILLS

Since its inception, the NCCVEH has provided education and skills related to children's vision and eye health for professionals in 43 states. This includes **technical assistance** in 30 states and **presentations** for school nurses, Head Start staff and others in 40 states.

Prevent Blindness' Vision Screening Certification Course certified over 4,000 individuals since 2009, who are skilled in performing evidence-based vision screening, referring for eye care, and tracking treatment outcomes.

NCCVEH's technical assistance to states and school districts included:

- developing or revising evidence-based guidelines for vision screening;
- language for vision screening legislation around children ages 0–17 years for states and school districts;
- recommendations for vision screening tools to meet state guidelines;
- resources for data and statistics for preparation of grant proposals; and
- developing guidance on vision milestones for babies age birth to 1 year.

The NCCVEH's technical assistance to more than 15 national organizations included:

- developing and updating an online vision toolkit with the National Association of School Nurses;
- developing vision screening guidelines for the National Head Start Association, and Parents as Teachers;
- reviewing national guidance on vision screening for the Center for Medicaid Services, American Academy of Pediatrics, the National Center for Early Childhood Health and Wellness, American Board of Pediatrics, and the World Health Organization.
